

TEACH is pleased to welcome an alternative Internet Service Provider (ISP) option on the new BadgerNet network. Independent telephone companies who are Access Wisconsin subcontractors on BadgerNet are also offering internet services over BadgerNet. The contract between Access Wisconsin and AT&T specifically allows independent telephone companies to provide Internet services to their local schools and libraries over BadgerNet.

There are now three Internet options on BadgerNet and they are: (1) "AT&T MIS on BadgerNet", (2) "AT&T's WiscNet on BadgerNet" and (3) the local independent telephone companies. If you indicated one of these ISPs as your ISP on the Excel sheets that were sent to you in October 2016 or in the Excel sheets that were sent in the last two weeks, that ISP will be your ISP during transformation from BCN to BadgerNet. No further action on your part is necessary.

If you select to get Internet service from your local phone company each school/library should have an E-rate eligible contract with that company and you will also be invoiced by that company. Schools and libraries may follow their same E-rate and procurement process they currently use for local ISP service. A form 470 must be filed by April 13, 2017 for ISP service. TEACH will continue to invoice the school either \$100 or \$250 per month for transport.
